## **KEY FUNCTION:**

Responsible for programming, setting and operating Company equipment to a high standard and in accordance with quality and health and safety requirements, Company policies, procedures, and systems in a culture of continuous improvement

Main Duties and Responsibilities of the post			
•	Ensuring the efficient and safe programming of production equipment, using the Company's off line programming system Alpha-cam for the creation of efficient programmes		
•	Taking responsibility for the maintenance and cleanliness of equipment being used, and ensuring the area is kept safe, clean and efficiently organised		
•	Setting equipment properly and in accordance with requirements, instructing and/or operating the equipment as required, always ensuring that company machine tool assets are working to required standards and in accordance with quality and health and safety requirements and Company systems		
•	Employing initiative and decision making to ensure that production is safe and effective		
•	Carrying out maintenance requirements to ensure the machine tools or equipment are being used to a high standard, and being alert to broken or damaged tools so that immediate corrective action can be taken		
•	Identifying, reporting and recording non-conformances and/or defects in accordance with Company policy, including ensuring containment actions when product no-conformance is discovered		
•	Upholding Company quality standards, policies and procedures, ensuring that all products conform to the required quality level before release from the work station, that all inspection checks are performed and recorded, and that all non-conforming items are identified, recorded and managed in accordance with quality department procedures		
•	Ensuring that equipment is maintained during the working shift and that the level of cleanliness is maintained to the satisfaction of supervisory/management staff between job change-overs and at the end of the shift		
•	Maintaining updated records, including status/verification of work instructions (works orders)		



- Ensuring that all in-cycle activities are performed as instructed, regardless of whether they are listed on the works order, eg. Deburring, gauge checking of part
- Ensure compliance with legislation, all Company held standards, policies, procedures and best practice
- Undertake other duties commensurate with the role, as instructed and/or notified from time to time
